POLICE REPORT

There had been four incidents in the village, all on the same date in April. Two houses had been broken into; £26.00 had been taken from the resident's bedroom whilst they were asleep; a house had been broken into but they had been disturbed and left empty handed; the abattoir had their office ransacked but nothing had been taken; the Black Bull Pub had an amount of cash taken. The police caught a couple of youths attempting to break into properties in Riccall some days later. At first questioning these youths had admitted to the burglaries in Escrick but under formal questioning refused to admit to the Escrick properties. The Police are satisfied they have identified the culprits for the Escrick incidents and have closed their files for these.

NORTH SELBY MINE

The Council received a letter from Mr Mike Slater, Assistant Director Planning & Sustainable Development stating that a notice has been served on UK Coal and other parties with an interest in the land with regard to the North Selby Mine complex at Escrick. The notice requires all buildings, plant and machinery be removed from the land within two years from the notice coming into effect June 15th 2011. The notice reflects advice received from a Planning Barrister at Kings Chambers.

Safety checks have been completed.

They are liaising with the 10k committee and are trying to raise sponsorship monies for this event.

Tarmac is not responding to requests to renew this lamp post and the clerk to contact Paul Sheppard at North Yorkshire Highways and ask for any other contractors who would be interested in this work.
