Mr Pitt, RJB Mining, gave a presentation on the proposals for the North Selby site. It is expected that demolition of some of the buildings will commence towards the middle of this year. RJB have applied for planning permission for the reduction of some of the buildings and change of use of some which will be retained. The proposal is to use these buildings for light industry, office and storage. Parish Councillors expressed concerned over increased traffic. RJB anticipate that up to 200 people will be employed at the site, as opposed to 700 when the mine was working at full capacity. However, EPC were of the opinion that these figures were purely speculation. Mr Peat invited members of the Parish Council to visit Whitemoor site which now has a number of occupiers on it and where the major works have been completed. After discussion it was agreed that EPC will oppose any future development and request that the area reverts to agricultural land, as per the original agreement. Mr Wilson will represent the Parish Council at the meeting of the York City Local Plan on 20 January.

Minutes

Minutes of the previous meeting were signed as a true record, having previously been circulated.

Matters Arising

Mr Forster reported that he had received no communication from Mitchell & Struthers regarding grass cutting.

Mr Hulley reported that the street lighting in the village is up to 1987 standard, ie three luminars per light. The recommendation is now for five luminars per light. The Bridges and Highways Dept recommend CDM white which would be easy to convert to our existing lights and improve our existing lighting at a low cost. Mr Wilson to speak to Mr Brooksbank.

Millennium mugs. To be distributed and those remaining to be sold.

Escrick Station/Dumpall. Mr Wilson had spoken to the Department of Environment at Selby who are of the opinion that this site is not dangerous and has no toxic waste.

Refuse collection. Mrs Casling reported that the changes for collection to remote properties as reported in minutes 13/12/99 will now be implemented.

Skipwith Road junction. A copy of our letter dated 16/12/99 has been sent to Halcrow for their consideration and reply.

Main Street. Letter received from Mr Bowe, NYCC regarding our request for road improvements on Main Street and the junction of the A19 to Red Bridge. He stated that he cannot include such works in his budget as he has to submit proposals and await assessment and subsequent prioritisation. He did, however, confirm that a scheme to drain and resurface a short stretch of Main St between the Post Office and Carr Lane has been submitted. The results of his application will be known in February/March.

Mr Wilson had received a petition signed by Carr Lane residents complaining about the condition of Carr Lane, the pavement, and particularly the junction with Carrs Meadow. EPC fully support the application which is to be sent to Mr Bowe, NYCC.

Escrick Estate Office. Mrs Casling reported that it looked likely that this application would be given approval by SDC, in spite of an earlier indication at a preliminary site meeting that the application would be rejected.

Minutes

Minutes of the previous meeting were signed as a true record, having previously been circulated.

Matters arising

Precept. SDC have advised that contrary to a previous notification, Parish Council precept requirements will not now be taken into account for the purposes of monitoring Council Tax increases.

Highway matters. NYCC advise that it is their intention to resurface the area around Carrs Meadow/Carr Lane in the near future. However, dependent upon budget, the work may have to wait until April 2000. They also expressed their thanks for our offer of £1000 towards the installation of kerbs on Main St and will write to us when their financial settlement for next year is resolved.

Selby District Rural Transport Partnership. Our comments have been passed to Arriva Yorkshire. The Rural Transport Officer has advised that there is a Government proposal to implement concessionary fare schemes for all elderly people commencing in April 2001. This proposal is subject to confirmation.

Refuse Collection. SDC advise that the new contractor is operating as far as sweeping is concerned, on an eight weekly frequency within the village, a twice yearly frequency on the A19, and on an as required basis on other rural roads within the Parish. Litter collection vehicles also travel through the district on a weekly basis. The policy for the change in refuse collections at remote properties has now been adopted by the Council. Individual requirements of residents will be catered for as far as is possible within the overall policy of the Council, however some householders may have to be visited to deal with specific problems.

RJB Mining. Mr Peat expressed thanks for allowing him to attend our meeting. His letter confirmed the Company's invitation for members of the Parish Council to look around the Whitemoor site.

A19/Skipwith Road junction. Halcrow UK inform us that they cannot justify the proposal of a signalised junction at the present time.

York City Local Plan. Mr Wilson and Mr Skilbeck attended the meeting on 20 January. Mr Wilson reported that Deighton Parish Council opposed RJB's plan to use the North Selby Site for light industry. Mr Wilson also reported that York City Council have not reached a decision on the green belt area and unless this is agreed the York Plan will be suspended for a year. Mr Wilson to consider the Parish Council's way forward.

However, Paul Gillmore (NYCC Highways) has suggested we use CDM TT White at a cost of £80 each and Mr Wilson will now speak again to Mr Brooksbank regarding the possible upgrading of the lights on Main Street and also the light at the Hollicarrs.
