Bottle bank

Lamp posts

Mr Brooksbank has reported that three lamp standards are cracked and will need replacing (Main Street, Carr Lane and Skipwith Road). The costs will be: Metal sleeve £180; new lamp £106; metal column £286; concrete column £386. For the new columns there will be an additional cost of approximately £250 for rewiring. It was proposed that we replace one per year and a decision as to which one and by which method will be taken at our next meeting.


It is proposed that the levy will be introduced with effect from 1 April 2001. An additional cost to EPC of approximately £60.

Mr David Ashton gave a warning that he is concerned that the City of York will be looking for a site to house a new waste disposal structure in the not too distant future. There will be a meeting at Priory St York at 10 am on 14 February.

We have received an invitation to the Chairman's Reception at County Hall on Friday 10 April. EPC Chairman to attend.

Wheldrake Road

Mr Skilbeck expressed concern at the state of the Wheldrake Road in spite of recent repairs.

Dr Craven reported that he has received two quotations for skateboarding equipment. As these are in the region of £20,000 he is to enquire whether there is a possibility of obtaining funding from elsewhere. Mr Forbes Adam reported that there had been a low take-up for Millennium funding.

Mr Hulley reported that QM school, the Parsonage, Escrick primary school and the Dower House have all expressed an interest in gas being brought to the village.

Hollicarrs Light - it is not the Parish Council's responsibility to provide a light at the Hollicarrs, but one should have been installed by the developer when the houses were built. It is suggested that the residents write to Selby District Planning authority.


Mr Wilson will write to the occupant of 1 Church Cottage to ask if it will be possible for her to park her car elsewhere. He will also enlist the help of the police authorities.

Mrs Horne reported that there was a lot of litter on the beck side in Carr Lane. Mr Reader will ask John to remove it.

Mr Wilson will arrange for a reminder to be placed in the Parish magazine regarding litter and dog fouling.

Mr David Nunns of the Ramblers Association spoke at length on Rights of Way. He also advised as to the way we should proceed if we wish to claim additional Rights of Way from long-term useage. Mr Wilson thanked Mr Nunns for his help and advice.

MINUTES:

Minutes of the previous meeting were signed as a true record, having previously been circulated.

MATTERS ARISING:

Bottle Bank - there have been no objections from any residents of The Glade re the siting of the bottle bank. Mr Wilson to speak to Mrs Casling about arranging the positioning the bank on a trial basis.

Emergency Committee. Mrs Durham and Mrs Horne have agreed to act as Emergency Officers.

Halcrow UK. A19 Bus Stop - Halcrow will write to us as soon as they receive a response from the Highways Agency.

Lamp Posts. The post in Main Street is to be replaced with a metal column at a cost of £286 plus approximately £250 for rewiring. Proposed Mr Hulley, seconded Dr Craven. The Parish Council intend replacing the two remaining damaged posts within the next two years.

Local Councils Association membership. This is to be renewed for the 2001/02 year.

City of York Local Plan. Mr Wilson explained the reasons why the Greenbelt Plan has been suspended for a year. City planners are worried about building on flood land and also the size and position of the greenbelt has yet to be agreed. EPC to write to York City Council and also NYCC to ask if we can be kept informed of developments and also ask NYCC if we can be represented. There will be a meeting on 20 June at Priory St. Volunteers are asked to attend.

Escrick Brickworks. Our comments have been noted by the Highways Agency who have asked their Agents to address the points raised. They have pointed out, however, that it is the responsibility of the police force to enforce speed limits.

Hollicars lighting. Mr Wilson has applied for funding for the installation of two lights at the Hollicars. He has also asked Northern Electric and our local contractor for estimates.

Mr Hulley will keep the Parish Council informed as to developments re gas installation.
