MATTERS ARISING:

Hollicarrs lighting: Funding applications are being considered on 29 January. Mrs Casling to enquire as to the result of our application.

Bottle Bank: This has now been removed from the Village Hall car park. A letter had been received from Mrs Robinson, of Robin's Nest to tell us that, although the bank had been removed, debris had been left which she and her neighbour had cleared away.

Bus shelter: Painting has been completed.

Escrick Station: County Councillor David Ashton is pursuing the matter of landscaping this area.

Golden Jubilee Mr Skilbeck stated that money had been donated from the New Year's Eve funds. The Parish Council also agreed to donate £170. Proposed Mr Forster, seconded Dr Craven.

Community Dental Services: Our comments have been sent back to North Yorkshire Health Authority.

Quality Parish and Town Councils – a Consultation Paper. Our comments have been returned to DEFRA stating that in the opinion of the Parish Council we already meet most of the standard requirements for quality status.

Darby and Joan Club: A letter of thanks has been received from this organisation.

Escrick Playing Fields Association: Letter received stating that they would appreciate help towards the purchase of the installation of a new toddler swing. The Association are to hold a consultation day on 23 February.

Emergency Committee: NYCC had replied that they would prefer the village primary school not to be used as a first choice emergency centre. However, the Parish Council had asked if the school could be used as an information centre, having previously obtained permission from Queen Margaret's School to use their premises as an emergency centre. Mrs Durham and Mrs Horne are proceeding with their plans to set up this Committee.

MINUTES:

The Minutes of the previous meeting were signed as a true record, having previously been circulated.

MATTERS ARISING:

Footpaths at Escrick Parish Council: Clerk to write to NYCC, Legal Services Department, to confirm that we wish the Lease to be renewed allowing access to the playing fields via a footpath.

Carr Lane, Escrick: Mr Wilson stated that he has been informed by SDC that repairs are to be made to the fencing in Carr Lane, despite Mr Jackson's letter in which he stated that he considered the fencing to be adequate.

Escrick Station. Dumpall have have still not landscaped this area in spite of a hefty fine. North Yorkshire CC is attempting to arrange a meeting between all interested parties within the near future.

Golden Jubilee. Mr Skilbeck reported that plans were going well for this celebration. The Committee is expecting to hear within the next two weeks whether or not they have been successful in their application for lottery funding. Mr Skilbeck also reported that the Jubilee Committee would be taking out their own insurance for events to be held on the Village Green.

Playing Fields: Dr Craven reported that the Committee has not yet lodged their application for lottery funding, but is holding many successful fund raising events.

Emergency Committee: Mr Wilson, Mrs Horne and Mrs Durham are to meet in the near future. Mr Wilson thanked Mrs Durham and Mrs Horne for their hard work to date.

Urban Grass Cutting: We will be informed in due course how much funding we will receive from SDC.

Code of Conduct: Mr Wilson attended a meeting at Selby and was informed that Escrick had been the first Parish Council to accept the Code of Conduct and sign the Declaration of Interests.

Temple - Funding Bid: This matter is still on-going. Mr Forbes Adam stated that he had now been given permission for the application to go forward. It is hoped to restore the Folly, provide benches, a permissive footpath and disabled access via Gassey Wood. Mr Forbes Adam thanked Escrick Parish Council and members of the public for their support.

The Glade: Lighting has now been upgraded.

Hollicarrs lighting: A cheque for £1376.25 has been received from SDC, Crime Prevention Budget, to provide two lights. It is hoped that these will be fully installed within the next two or three months.



Litter: Mr Wilson reported that it seems there may be difficulty in obtaining the services of a pavement/road sweeper. Mr Reader has resigned from his post, although Mr Wilson was under the impression that he would continue with his services until a replacement was found. Mr Wilson will speak to Mr Reader again.

At the moment there is a vacancy due to the resignation of Mr Hulley. The vacancy is to be advertised.

ESCRICK PARISH COUNCIL.

The annual General meeting of the Parish council will be held in the Escrick Club on Monday 30th April 2002 at 7.30pm

Chairman`s report.

The Parish precept remains at £8000, which has been held for the past four years. This year it has been necessary to replace a number of street lights due to corrosion. The replacements are made of metal, and are much safer, and have a longer life. We are reviewing the overall standard of lighting in the village, and as a result of recent trials, the lighting in the Glade will be updated. It is also planned to increase lighting in some areas where it is necessary for the safety of residents.

Roads and footpaths.

Repairs to roads and footpaths still cause problems. We applied for funding for a new footpath in Carr lane, from the A19 junction to the Red Bridge. Our application was unsuccessful, however we will continue to apply as this is the only road in the village without a footpath.

Planning

There is still no decision on the future of the North Selby Mine site. The winding towers have been removed, the shafts have been capped and the bunds have been landscaped. The future of the site rests with the York City Council, and the conclusions of the York Local Plan.

It has been a busy year for the Planning subcommittee, led by Brian Forster. The bungalow on Skipwith Road was demolished and two new houses have been built on the site. The old Police houses in Carr Lane have been renovated and are for sale. The Dower House is to be converted into flats. These are just a few of the many applications which the council has received over the past year. My thanks to Brian and his subcommittee.

Village Green.

The village green has become an accepted part of village life, due in no small measure to an enthusiastic Village Green subcommittee led by Peter Calvert. A number of events are planned by the Jubilee Committee, to take place on the green on June 3rd.

Neighbourhood Watch.

My thanks to Mike Russell for his continued work over the past year. There have been a number of burglaries over recent weeks, so we need to be vigilant and report any suspicious vehicles or persons to the police.

Emergency Plan.

The emergency plan is almost complete. My thanks to Mrs Durham and Mrs Horne for their hard work in compiling a very comprehensive emergency plan. Details will be published in the coming months.

Chairman`s Note

The Government plans to devolve more power to Parish Councils, with hopefully, the finance to back it up. The Parish Council has decided that we should have a village development plan. This will be formulated to examine all aspects of village life; roads, footpaths, lighting, recreation, etc. and how they might be improved in the future.

Sadly, one of our councillors, Bill Hulley, has resigned from the council due to family illness. Bill has been a valuable member of the council and his experience and advice will be missed.
