Policies and Procedures

23086: Standing Orders and Financial Regulations:

a. Resolved to accept the amendment to the Standing Orders and Financial Regulations. The Public Contracts Regulations lower threshold for tendering has been altered to £30,000 from £25,000.

Maintenance

23087: Maintenance issues:

- a. Update on maintenance issues given by Chair; The paving slabs on the footpath at the top of Carrs Meadow have been levelled by Joseph Rowntrees Housing Trust.
- b. Litter picking has been done on Skipwith Road by SDC and Escrick Park Estate at the beginning of March. It was reported that there is still a lot to do. SDC have added it to their worksheet to do again.
- c. Update was given on the Walnut trees on the village green. Proposal to lift the trees (rather than crowning them) in line with highway statutory clearance levels which is 5.2 metres above ground level. Resolve to agree timing of the works. It was resolved to recommend that the work is carried out in the Autumn as suggested by the VGA.

Playing Field / Play Area

23088: Playing field update:

- a. Maintenance inspections have been done and no further issues in the play area to report. Mole / rabbit holes have been reported to the Playing Fields Association who are going to take action.
- b. No further update on the proposed coppicing in the Playing Fields woodland area. Was due to start work on 28th March. No progress to date.

Planning

23089: Planning, new applications:

- a. 22023/0126/HPA. The Old School, Escrick Park Gardens, Escrick. Alterations to principal elevation to remove door opening, and to convert two windows to full height glazing in keeping with the existing property. Extension for comments granted to 7th April 2023. No objections or comments raised.
- b. 2023/0110/FUL. Traves A, Abattoir, Main Street. Residential conversion of existing buildings into 4 No 2 bedroom dwellings, erection of 1 No 3 bedroom and 3 No 4 bedroom dwellings together with associated garages and alterations to an existing building to form a store/garage for Langrigg, together with associated works including an improved access to Main Street. Councillors have no objections to the application however they request that the developer gives due consideration to the type of vehicles allowed on property drives (cars not commercial vans) and in particular limitations on street parking rules for all future residents of this cul-de-sac. This is especially relevant given the limited vehicle space available on this development.

23090: Planning ongoing:

a. 2022/1280/FUL. Black Bull, 91 Main Street, Escrick. Conversion of existing public house with landlords accommodation and lettable rooms to 3 No dwellings with parking to rear. The PC objection has been submitted to SDC. Awaiting decision. No further update.

23091: Planning determinations:

a. No planning determinations received.

23092: Planning working group:

a. Nothing to report.

23093: Selby Local Plan and Heronby proposal:

a. Planning update received from North Yorkshire Council; Elected members have agreed that there will be one overarching strategic committee and six committees aligned to the MP constituency-focused area committees. Work to set up each committee is under way. At the moment the policy basis will be the existing district plans, however, the council is in the process of embarking on the development of a new local plan for the whole county within a five-year period. The Assistant Director for Planning is Trevor Watson and the area sits in Community Development.

Other items

23094: Village shop:

a. Cllr Hawes gave an update on the Village Shop project. New door has been installed. A change of use application to be submitted by the parties involved if required.

23095: Installation of full fibre optic networks in the village:

a. Factco have confirmed that the plans are going ahead which still include the pole installation on Wenlock drive. Residents of Wenlock area have met with the Nigel Adams MP and Howard Ferguson to express their concerns about the installation of poles. Clerk to write to Nigel Adams MP with a timeline of events stating that the Parish Council have not received any plans from Factco as requested. Factco have not tendered Superfast North Yorkshire for any work in Escrick. Residents have been advised to write and object to the poles. Concerns have been raised that Factco have not given 28 days' notice to install the poles. It was reported that poles are also going to be installed in Dower Chase.

23096: Escrick Primary School:

a. Cllr Chambers has had a meeting with the Head of Estates for the SYMAT and the Chair of Governors to discuss management and access for the footpath next to the school. It was agreed that there will be no legal agreement drawn up and the Parish Council will not take responsibility for any of the trees. Volunteers organised by both the Parish Council and parents of school children will tidy the path 2-4 times a year.

23097: Correspondence received:

- a. YLCA; White Rose Updates and general correspondence noted.
