# **Escrick Parish Council**

Minutes of Escrick Parish Council meeting held in Escrick & Deighton Club at 7pm on MONDAY 5<sup>th</sup> SEPTEMBER 2022.

22171: Welcome: Chair welcomed councillors and members of the public to the meeting.

22172: Co-option of new councillors. Resolved to co-opt Stewart Allen.

#### 22174: Declarations of Interests: None.

## 22175: Public correspondence received:

- a. Email received regarding the visibility splay on the junction of Wheldrake Lane/Skipwith Road. Clerk reported this to Highways upon receipt of the email for safety reasons.
- b. Various correspondence from members of the public regarding the Local Plan / Heronby. Noted by councillors. Clerk to advise residents where to send a formal response.
- c. Land and Escrick railway cutting Confirmation received from a resident that North Yorkshire County Council have issued an Enforcement Notice on Escrick Cuttings to stop further depositing materials and infilling on the land. Councillors acknowledge this and expressed thanks to the resident for pursuing this.

#### 22176: Public session:

- a. Concern raised about potential confusion regarding the dates for the Neighbourhood Development Plan referendum and the closing date for the Local Plan consultation. The referendum for the NDP is 6<sup>th</sup> October and the closing date for the Local Plan consultation is 5pm on 7<sup>th</sup> October. Clerk to advertise on the Parish Council website/Facebook page and on the PC notice board. It will also be made clear in the Parish Magazine.
- b. Concerns raised about the Local Plan consultation portal being difficult to navigate.
- c. Resident joined the meeting to give an update on the Jubilee garden. It was confirmed that a full breakdown of both the project and costs will be presented to the council at least three days in advance of the next Parish Council meeting.
- d. The same Resident expressed concern about the Parish Council providing financial support to an action group in the village.

# Highways

# 22180: Highways: Skipwith Road

a. The Village Gateway Scheme has still not progressed. Clerk to follow this up again with NYCC.

#### Maintenance

#### 22181: Maintenance issues:

- a. No further maintenance issues to report.
- b. Contractors have carried out work on the Sycamore tree on the footpath next to the school. After making enquiries with NYCC, it was confirmed that the school academy trust have now taken on responsibility for this path. Clerk has been in contact with the school to request payment for the work on the Sycamore and to do further work along the path. This also includes contacting adjacent properties to cut back a fir tree and overgrown nettles and vines at the request of a resident.
- c. Escrick Playing Field Association have gone out to tender for work done on the trees in the playing field. To consider quotes received at the next meeting.
- d. The defibrillator had an urgent software recall in August. The software has now been updated and the battery has had to be replaced. It is now all in working order.

# **Planning**

# 22182: Planning, new applications:

- a. 2019/0045/EIA. Land Between New Road and Wheldrake Lane, Wheldrake Lane Escrick. Outline application for redevelopment of the former North Selby Mine site to a leisure development comprising of a range of touring caravan and static caravans with associated facilities. Amended plans, amended description and additional information. To note previous objections and no further comments to make.
- b. 2022/0964/FUL. Bell Farm, Riccall Road, Escrick. Erection of a single building for the manufacture of wooden sheds and outbuildings. No comments to report.

# 22183: Planning ongoing:

- a. 2021/1375/HPA. Grove House, Skipwith Road, Escrick. Placement of gas tank in garden (retrospective).
- b. 2022/0357/TCA. Hellings House, 73 Main Street, Escrick. Application for consent to crown reduce 2No Beech trees (T1 & T2) by 33% and crown thin 1No Fir tree (T3) by 10 30% in the conservation area.
- c. 2020/1007/FUL. Creation of 10 car parking spaces (retrospective). The Parsonage Country House Hotel, Main Street, Escrick. Permitted. Concerns about visual impact and drainage raised with SDC.
  Councillors to raise these ongoing queries at a meeting with SDC to be held on 8<sup>th</sup> September 2022.

## 22184: Planning determinations:

- a. 2021/1484/HPA. Field View, Skipwith Road, Escrick. Rear single storey extension. Permission granted.
- b. 2022/0414/FUL. Three Hagges Woodmeadow, Hollicars to Scorce Bridge, Escrick. Erection of part polythene covered/part shading mesh covered polytunnel. Permission granted.

## 22185: Planning working group:

a. Nothing further to report.

# 22186: Selby Local Plan and Heronby proposal:

- a. An update was given on the feedback received from the local parish councils and funding agreed.
- b. Councillors reviewed the previous feedback sent to SDC in March 2021 and considered feedback for the current consultation taking into account views expressed from residents during the NDP consultation. To be finalised and agreed at the October Parish Council meeting. Concerns raised that the feedback portal is not very user friendly. Concerns to be fed back to SDC.
- c. Timescales agreed for submitting feedback. Consultation ends on 7<sup>th</sup> October 2022 at 5pm. Parish Councillors to meet a representative from SDC on Thursday 8<sup>th</sup> September to discuss the proposals. Drop-in event has been organised by SDC for 9<sup>th</sup> September between 2-6pm in Escrick Village Hall.
- d. Clerk to add portal instructions to the PC website to aid their response to SDC including alternative options to express dissatisfaction in the process if required.

**Halt Heronby Action group update:** Chair opened the meeting for representatives from the Halt Heronby Action group to give an update.

- e. Councillors received a full update on organisation, contacts, responsibilities and group structure.
- f. Future needs from Escrick Parish Council and plans were discussed. It was resolved that any grant money donated by EPC should where practical but not exclusively be used for goods located within the parish.
- g. Funding requirements and options to meet the proposed budget requirements were discussed.
- h. Councillors resolved to use \$137 monies to fund the agreed £500 donation. Community account to be opened by the action group.

#### 22187: Planning, Neighbourhood Plan:

a. Cllr Rees gave an update on the Neighbourhood plan. Referendum date is 6<sup>th</sup> October 2022 whereby residents will be able to vote to adopt the plan. Full details will be posted to residents by SDC and the NDP group to advertise the referendum.
