

Publication Local Plan

Pre-submission Publication Local Plan consultation – 26th August to 7th October 2022.

Selby District Council is holding a six-week consultation on the proposed submission documents relating to the Selby District Local Plan, from **Friday 26th August to 5pm on Friday 7th October 2022.**

Step 1

Step 2

If you have made comments through Objective (our online consultation portal) during a previous consultation stage of the Local Plan through either the Preferred Options consultation (January to March 2021), Additional Sites consultation (August to September 2021) or the Evidence Base documents (September to October 2021) you will have received an email confirming your username and password.

If you have not previously made comments, you will need to follow the instructions to register.

If you submitted your previous comments via post or email and **not** through our online consultation portal, we will have created you an account and uploaded your comments to our online consultation portal and you will have received an email with your username and password.

As you navigate the document – you will be able to populate each topic with your comments.

If you have made comments during a previous consultation stage of the Local Plan through either the Preferred Options consultation (January to March 2021), Additional Sites consultation (August to September 2021) or the Evidence Base documents (September to October 2021) you will have received an email notification from our online consultation portal confirming that comments you have previously submitted have now been made public along with the Council's response.

When you have logged in, the login icon switches to your profile name, and you will see 'My Submissions' on the drop-down list.

If you select this, you should see a page with all your comments on cards. You can then click on the card to see the comment and the Council's response(s), as well as download a pdf version of this.
