Main Street and Escrick Park Gardens, Escrick

Statement of Reasons for proposing to make the Orders

The proposals to introduce School Keep Clear restrictions are in response to requests made by the Parish Council and local residents that parking along Leeds Road and Union Lane can cause problems of:-

- 1. Obstruction
- 2. Visibility
- 3. Safety

North Yorkshire County Council therefore proposes Waiting Restrictions:-

- a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising
- b) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians)
