3. To receive and approve the Minutes of the previous meetings

3.1. 7th September 2015

Cllr Reynolds asked that the report of his arrival be moved outside of the District and County Councillor's report item.

Cllr Coulson asked that the request that she had made at the last meeting for the Clerk to write to the Estate office and ask them not to allow their maintenance vehicles to park on the grass verges on the junction of Skipwith Road and the A19 be added.

RESOLVED: Subject to the above amendments, the minutes of the Parish Council meeting held on 7th September 2015 were moved, seconded and approved as a correct record.

4. To receive correspondence

The Clerk had circulated an email from Kevin Power about the road junction of Skipwith Road and Wheldrake.

RESOLVED: That the Clerk write to Highways stating that Escrick Parish Council supports Mr Power and suggesting that the 40mph sign be moved further back towards Skipwith was proposed, seconded and approved.

5. To discuss the keeping of chickens in the village

Cllr Reynolds had asked for this item to be added to the agenda because he had been copied in on complaints that had been received about the noise from cockerels kept by residents in the village. It was felt that Escrick is a rural village and that the noise from crowing cockerels was perfectly acceptable. The Parish Council supports the rights of residents to keep chickens including cockerels.

6. To receive an update from the Clerk on issues not otherwise on the Agenda

The Clerk reported that a letter from Guest Walker had been received but that it merely stated that they were looking into the matter and would be in touch soon. The Clerk was asked to chase this up.

7. To report the External Audit result

The Clerk reported the External Audit result had been received and the result was that the annual return was in accordance with proper practices. The Chairman asked that it be minuted that the Parish Council expressed their thanks to the Clerk.

8. To discuss the purchase of a Defibrillator for the village

Cllr Goode had met with Cllr Rowson and had applied to the British Heart Foundation who advised that after 1st October it may be possible to get the defibrillator, training and cabinet free of charge from the British Heart Foundation. Cllr Goode then reapplied after this date and it looks like the defibrillator for the village will be fully funded. The best place was felt to be outside the club but an electricity source would be required. Cllr Goode had contacted Mr Forbes Adam to ask permission to put it outside the club and this had been granted, however, it was also felt that the current management committee of the club should be consulted.

RESOLVED: Subject to a satisfactory quote for the electric connection and permission from all interested parties, it was proposed that the installation of the defibrillator should go ahead. This was seconded and approved.

9. To approve the repair of the War Memorial in the Churchyard

Cllr Casling reported that several donations had been received towards the repair of the War Memorial in the churchyard and there should now be enough to cover the cost of the quote received by Cllr Reader previously. However, a "faculty" was required from the diocese and the next meeting was not until December so the work would not be able to go ahead before the November Remembrance Sunday commemorations. Other quotes had been sought but had not been anywhere near the quote obtained by Cllr Reader.

RESOLVED It was resolved that Cllr Reader advise the contractors who provided the quote that we would like them to go ahead with the work in January subject to the Faculty. This was seconded and approved.

10. To approve the transfer of the support for the Escrick.org domain name and email accounts

Cllr Rowson proposed that he took over the administration and support of the Escrick.org domain name and associated email from Mr Smowton who had previously done this. The costs involved in this would be \pounds 37.20 + VAT for email hosting, \pounds 10 + VAT one off fee to transfer the domain name from the registrar that Mr Smowton used to the one Cllr Rowson uses. \pounds 49.99 + VAT to extend the domain name for another 5 years as it is due to expire in March 2016.

RESOLVED: That the proposal outlined above be carried out was proposed, seconded and approved.
